THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2023/2418 of the European Parliament and of the Council of 26 October 2023 establishing an instrument for the reinforcement of the European defence industry through common procurement (EDIRPA), and in particular Article 12 thereof,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012 ('the Financial Regulation')¹, and in particular Article 200 thereof,

Whereas:

- (1) Commission Implementing Decision C(2024)1700 of 15 March 2024 on the financing of the instrument for the reinforcement of the European defence industry through common procurement (EDIRPA) established by Regulation (EU) 2023/2418 of the European Parliament and the Council adopts the EDIRPA work programme for 2024 - 2025.
- (2) The Commission launched the calls for proposals EDF-EDIRPA-2024-FNLC-AMD, EDF-EDIRPA-2024-FNLC-AMMO and EDF-EDIRPA-2024-FNLC-LSP on 25 July 2024. The description of the calls is provided in Annex 1.
- (3) These calls for proposals were closed on 25 July 2024. 12 proposals were submitted in response to these calls.
- (4) The evaluation of the proposals was carried out in accordance with the provisions of Article 200 of the Financial Regulation and Article 11 of Regulation (EU) 2023/2418.
- (5) Based on the admissibility, exclusion, eligibility, selection and award criteria laid down in the multiannual work programme and published in the calls for proposals, 5 proposals have been selected to receive financial support under the EDIRPA. Another 5 proposals have been placed on a reserve list.
- (6) This Decision concerns proposals which – under recital 24 of Regulation (EU) 2023/2418 – require a Commission award decision in *mode décisionnel*.

HAS DECIDED AS FOLLOWS:

Article 1

The 5 proposals listed in Annex 2 are awarded a grant under the 2024 EDIRPA calls for a total maximum grant amount of EUR 300,000,000.00. The 5 proposals listed in Annex 3 are placed on a reserve list.

The list of awarded proposals mentions the corresponding call and, where applicable, the topic, the consortium's coordinator and its country of establishment, the estimated total eligible costs of the action and the maximum amount awarded.

Article 2

Proposals listed in Annex 3 (reserve list) successfully complied with the exclusion, eligibility, selection and award criteria laid down in the calls text but are considered rejected for lack of budgetary appropriations.

Proposals in the reserve list may be selected for grants in case budgetary appropriations are available.

Moreover, where the proposals selected for funding failed the grant preparation, proposals from the reserve list under the same call might be selected for funding, in the strict order of their ranking.

In case the available budget appropriations are not sufficient to finance the grant of the next ranked proposal under the relevant call, the available amount will be transferred to another call to fund proposals in the order of their ranking and in compliance with the budgetary provisions foreseen in the call conditions.

The reserve list will be valid until 31 December 2025.
